Dining

Beverages

Staying Power

Two (2) certificates (Transferable) for a complimentary night stay for 2 guests, when the first night is paid for at the rack rate of the rooms at the hotel, however above said two certificates cannot be combined for one visit

One (1) certificate (Non-transferable) for a complimentary night stay in a standard room for 2 guests (inclusive of buffet breakfast at the coffee shop) at the hotel

Weekend Unwind

Four (4) certificates (Transferable) for a flat 10% off on all weekend packages at any property of the hotel group

Celebration Cake

Two (2) certificates (Non Transferable) for 1 kg complimentary celebration cake (except Ornamental cake) valid while dining only on a table of minimum 4 guests

Half Price Celebration Cake

Four (4) certificates (Non Transferable) for a flat 50% off on cake of minimum 2kg and max 5kg (except Ornamental cake)

The dining certificates are valid at any of the restaurants at the hotel unless otherwise specified

Terms and Conditions

General Conditions

- Club membership has no cash value, is non-transferable and members must be 18 years of age or above to join. The membership period is 12 calendar months from the date of enrolment.
- Club benefits cannot be used in conjunction with any other discounted offer.
- Club reserves the right to change, modify or amend the membership benefits, participating hotel & restaurant listings and any terms and conditions communicated in this or any other Club material, at its absolute discretion at any time, without giving a reason and without notice.
- Without prejudice to any other mode of proof, through payment for the Club, a member accepts these terms and conditions, as amended from time to time, and agree to be bound by them.
- Club reserves the right to cancel or suspend membership at any time, if it is suspected that the membership is being operated fraudulently.
- Any certificate or membership kit issued as part of the membership shall not be replaced if lost or stolen.
- Should, for any reason, the Club membership concept be discontinued, the Hotel and Resorts included in Club shall have no financial liability to the member.
- All taxes shall be borne by the members. Members must settle their bills at the time of departure.
- Membership refunds can be considered only if the membership card is un-used and the full package including gift certificates are returned unused in full along with a letter requesting cancellation within seven days of enrolment. All such requests should be sent to the local Club Office.

Accommodation Conditions

- Accommodation benefits (including rates and certificates) are subject to space availability and advance reservations are required. Limited rooms are available at the discounted rates and the accommodation certificates may not be accepted during periods of expected high hotel occupancy.
- Blackout dates may apply during special events such as Christmas Day, New Year's Eve etc. Members should check when booking to ensure the membership benefits are available on such dates.
- Any member who does not show for a booking on the accommodation certificates will not be able to avail the same certificate again.
- Hotel may promote seasonal rates within a fourteen day and conditional booking period that may be lower than Club rates.

Dining Conditions

- The member's dining benefits is offered on all standard adult meals for breakfast, lunch and dinner and the membership card must be presented at the end of the meal or when requested in order to receive the benefits.
- A maximum of one membership card will be accepted per table/party.
- The value of one free meal is calculated by dividing the total portion of the food bill by the number of persons dining (i.e. 2 people = 50%, 3 people = 33%, 4 people = 25%, 5 and up to 14 people=20%, members dining alone =20% off the food component of the bill). Children below 5 years of age will not be considered while calculating food discounts.
- Dining benefits are not available on packages inclusive of accommodation and meals or any other special offer.

- Dining benefits are only valid for the food portion of the bill (excludes all beverages). A flat 20% discount will apply on beverage consumption in the restaurants and the hotel's bars.
- Dining benefits may not be available during special periods such as Christmas Day, New Year's Eve and Food Festivals etc. Members should check when booking to ensure the membership benefits are available on such dates.

Certificate Conditions

- Members must state their intention to use their membership rates and accommodation certificates at the time of reservation.
- Members cannot use two (2) certificates together.
- Certificates are valid for one time use only and must be surrendered at the time of use. These can not be redeemed for cash and are valid within the dates mentioned.
- Certificates are applicable as per the terms of usage stated on the front or the back of the voucher.
- Certificates cannot be used in conjunction with any promotion or over Christmas Day, New Year's Eve, Food Festival etc.
